TERMS & CONDITIONS

1. Introduction

2. Definitions

2.1 "Applicant" refers to a registered user who utilizes the Apply with Edu4u service and possesses an account in the UCAS system with the Service Provider's buzzword or who applies for studies at a university outside the UCAS system with the assistance of the Service Provider as an agent or representative.

2.2 "Non-Applicant" refers to a person who does not have an account in the UCAS system with the Service Provider's buzzword (and with the Service Provider registered as an agent/representative) or when a person applies for a master's degree directly via the university's portal not through MasterApply and without the Service Provider registered as an agent/representative. 2.3 "Service Provider" refers to GENERAL CONSULTING & SALES MGNT LTD.
